

Selby District Council Core Strategy EiP

Statement of Common Ground between Selby District Council (SDC) and James Perry in relation to public transport and other services and facilities in Fairburn.

Public transport services

SDC can confirm that agreement has been reached between Mr Perry and the council in relating to the information exchanged between both parties in connection with public transport services at Fairburn (see timetable details below together with supporting email confirmation received from Mr Perry).

Other services and facilities

Under background Paper No. 5 (CS/CD22d) Fairburn was listed as having three out of the four services listed (Primary School, General Store and Post Office). Both parties have agreed that Fairburn only has one of the services listed (primary school). It no longer has a general store or post office within the village. This is therefore an official revision of the information which the council originally provided in relation to facilities at Fairburn.
